Residency for Tuition Purposes- Required and Supplemental Documents

Students who were classified as non-residents at the time of their admission may be eligible to establish residency for tuition purposes. To qualify, students must be able to document their “intent” to establish Washington as their permanent domicile (residence) at least 12 months prior to the start of the quarter for which they are applying.

FINANCIALLY INDEPENDENT STUDENTS

Financially independent student: You have not and will not be claimed as a dependent on anyone’s federal income tax return and have not and will not receive significant financial assistance in any form directly or indirectly from parents, relatives, legal guardians, or others for the current calendar year and for the calendar year immediately prior to the year in which residency application is made. Spouses do not qualify as “dependents” for residency purposes. If you are 24 or younger and consider yourself financially independent you must provide a copy of the first and signature page of your parent or legal guardian’s federal income tax return. Please allow at least two weeks before inquiring on your application and allow six weeks for processing.
